Agenda

In addition to finally socializing again and introductions to each other, several topics will be up for discussion this year including:

- Appointment of an interim Board and Officers pending resumption of general elections in Spring, 2024. We are doing this so that we may get back on the proper schedule for elections and allow everyone the chance to consider running for the Board and various elected positions;
- We will consider an amendment to the Bylaws that would allow us to meet via electronic means should we
 ever end up in the same situation that we have been in since 2020. Our current Bylaws require
 Face-to-Face meetings once per year and to hold elections. This revision, if adopted, would allow us to
 meet via electronic means should in-person meeting be precluded by State or Federal law or restrictions;
- The current state of the treasury will be presented;

- An annual update on the work undertaken by our Frequency Coordination Team will be presented;
- Consideration of a proposal to add additional VHF allocations to the current repeater pairs available for coordination will be further discussed (held over from 2019);
- The status of the amateur allocations will be discussed in general.

Proposed Bylaw Amendment language:

Current: ARTICLE VII: MEETINGS

An IRA membership meeting shall be held at least annually at such place as the President shall order. Both membership and board meetings may be called by the President at his discretion, or by majority vote of the IRA Board of Directors. Notices of all membership meetings, with the proposed agenda included, shall be sent by first class mail, by the Secretary/Treasurer, to the entire membership at least 30 days before the time of the meeting. Only such business as is designated in the notice shall be transacted at this membership meeting.

Proposed: ARTICLE VII: MEETINGS

An IRA membership meeting shall be held at least annually at such place as the President shall order. Both membership and board meetings may be called by the President at his discretion, or by majority vote of the IRA Board of Directors. Notices of all membership meetings, with the proposed agenda included, shall be sent by first class main, by the Secretary/Treasurer, to the entire membership at least 30 days before the time of the meeting. Only such business as is designated in the notice shall be transacted at this membership meeting. (unchanged)

Should the membership be precluded from meeting face-to-face at least once per annum, the President may call an electronic meeting to occur using technology that will allow video and audio of all attendees to be uniformly enjoined. The membership may, at their discretion, participate with or without audio and/or video input. The Board and Officers must participate with at least a full duplex audio connection. Non-Face to Face meetings will only be permitted should State or Federal laws prohibit the gathering of the membership in person. (added text)
